SUBJECT: ITINERANT ELEMENTARY ARTS EDUCATION TEACHERS

In the 2019-20 school year, elementary schools will be assigned a base allocation of personnel to support instruction in the various arts disciplines (Music, Dance, Theatre, and Visual Arts). Schools may supplement this allocation by purchasing additional Elementary Arts Education Teacher days in the discipline(s) of their choice. In order to fund one FTE within a discipline, individual schools are encouraged to pool their resources within their school families. Purchases will be processed in the order of receipt and are contingent on the availability of staff. It is the responsibility of the school to purchase/provide necessary supplies/text books for arts instruction.
