Job Description: The Alternative Education and Work Center teacher provides instruction to students in compliance with District, State, and Federal Guidelines, using the independent study instructional strategy for the high school drop-out recovery program.

Salary: The salary will be based on the current negotiated Teacher Hourly Rate schedule.

Duties:

- Assess the needs of students, determine instructional objectives which will best assist students in meeting their identified needs; use appropriate assessment techniques to measure student achievement
- Maintain a learning environment designed to stimulate interest and attendance in the educational environment conductive to maximum learning participation
- Provide for continuous evaluation of student progress as well as administer District and State assessments including CAHSEE, Smarter Balanced, etc.
- Maintain accurate and timely independent study, attendance and student records
- Correct/grade and record (post to contract) student work within 2 weeks of turn in
- Participate in professional/staff development opportunities
- Perform other duties as assigned in accordance with the District-UTLA agreement
- Maintain classroom materials and use of appropriate and current course contracts
- Provide one-on-one instruction in an independent study methodology
- Follow up individually with students at least once per week to assign work and review corrected work and to encourage persistence toward program completion
- Ensure that students are completing courses within a reasonable timeframe
- Sign and date weekly assignment sheets, and keep an appropriate work sample for every student in accordance with Ed Code and CCR
- Call home when students miss appointments (in accordance with SB65 guidelines)
- · Provide outreach consultant weekly, with a list of hours completed by students
- Motivate adolescent students to successfully learn
- Interact with parents to achieve student success
- Issue credit slips.

- Recent successful teaching experience with "at risk" youth

- Knowledge of /experience teaching Adult Independent Studies
- Knowledge of Language Arts and Math teaching strategies
- Knowledge and Maintenance of classroom materials and use of appropriate and current course contracts
- Experience administering District, State and National assessments
- Knowledge of District, course outlines and grading procedures
- Ability to build and maintain a learning environment designed to motivate and retain students
- Effective organization, interpersonal, written and verbal communication skills
- Experience in classroom management/Instructional methodology for secondary students
- Recent teaching experience in adult school academic subjects
- Strong record keeping and organizational skills
- Sensitivity in working with a culturally diverse population of adolescents
- Ability to use computers as a teaching tool in the classroom
