Position Offered: ESL Teacher Advisor, North Valley Occupational Center

Job Description: Responsible for planning and implementing ESL program, including placement assessment of new students and end-of-term promotional testing.

Salary: The salary will be based on the current negotiated Teacher Hourly Rate schedule.

Duties:

- Coordinate and manage the ESL program.
- Plan and implement registration procedures for ESL students.
- Assess new students for placement using DACE ESL Placement System; complete intake procedures and paperwork.
- Prepare systematic promotional testing plan and implement school-wide procedures for administration of DACE Promotional Testing Battery; monitor and collect promotional testing results.
- Work collaboratively with ESL faculty on program articulation; facilitate and lead ESL department meetings.
- Assist teachers with instructional materials; assess and monitor textbook needs and place orders for ESL department.
- Support professional development opportunities for ESL teachers.
- Attend all Division ESL Advisors' meetings.
- Other duties as assigned in accordance with LAUSD/UTLA Collective Bargaining Agreement.

Preferred Qualifications:

- Bilingual English/Spanish
- Experience teaching ESL to adults
- Experience with ESL program coordination, intake assessment of students, and management of ESL Promotional **Testing**
- Knowledge of ESL teaching strategies, including cooperative learning
- Knowledge of curriculum and DACE Course Outlines of all ESL levels
- Recent experience presenting to small and large groups of teachers
- Organizational skills and attention to detail
- Strong skills in verbal and written communication; familiarity with computer applications
- Ability to work with students and collaborate with faculty and administration
- Work well with others and accomplish tasks in a "team" environment

A valid California Teaching Credential with a designation to teach English as a Second Language
