School leadership team has a proven record of success. The school's emphasis on a personalized learning environment immerses students in interdisciplinary studies focused around the broad health care career pathway and helps ensure the curriculum is relevant, engaging and challenging. The school plan offers several CTE courses which are presented in a ladder of difficulty sequence. Students receive work-based learning in the form of a CPR certification class, internships, hospital visits, site visits, mentorships, and career panels. Following three years of immersion in health care and medical thematic learning and work-based learning, all students will generate and develop their own individualized senior project to culminating their studies at AMA. The project is student-driven, ensuring a high level of engagement; the project concurrent with the four-year portfolio will provide a measure of how the student has internalized and can utilize the habits of mind/heart along with academic and career knowledge. The portfolio and project will be presented to a panel of peers, teachers, parents, business advisory members, and community members during the spring semester of the senior year. All students will have the opportunity to meet the A-G requirements for entry into the CSU/UC systems and students will be encouraged to take AP or honors classes as they progress through AMA and to dual enroll in college classes through the existing teacher team's established relationship with local community colleges. Students may also obtain state certification following the Certified Nursing Assistant Capstone CTE class. Student teams will participate in HOSA, Model United Nations, Project Citizen, CHAMPS Camp nutrition and physical mentoring of feeder middle and elementary schools, and community health fairs further developing their collaborative problem solving and leadership s

Mentors and counselors will provide guidance in the selection of academies to match students interests. In addition, students will participate in project-based learning, will be required to develop service learning projects for local and global communities, and must create reflective portfolios to self-monitor individual progress. Multiple sources of enrichment are proposed for students who achieve subject matter mastery (Advanced Placement courses, college classes, on-campus peer-mentor programs, and local internships). All the Academies require that students lead quarterly individual conferences with their parents/guardians. This will enable students to examine and evaluate their own data, and articulate their progress toward mastery of standards.
