LAUSDnet Privacy Policy (2018)

Thank you for visiting the Los Angeles Unified School District (LAUSDnet) website and for reviewing our privacy policy. This privacy policy discloses the ways our website gathers, uses, discloses, and manages a website user's personally identifiable information ("PII").

PII is information that can be used to distinguish or trace a person's identity. PII may include a person's name or address, parent and family names and addresses, social security number, and geolocation data, among other data.

We collect no PII unless you choose to provide that information through use of the L.A. Unified website.

Some of our webpages (such as on-line order forms, conference and training registration forms, information request forms, notification and alert request forms, and other forms) let you voluntarily submit PII. In those cases, every attempt will be made to protect your privacy. LAUSDnet cannot however, provide any guarantees as to the absolute security of your personal information.

For more information about how we record non-personal information about your visit or how we use information that you voluntarily submit, continue reading:

Non-Personal Information Recorded by LAUSDnet:

If you visit us and do nothing more than browse the site, read pages or download information, the site's operating system will automatically record some general information about your visit.

During your visit, the LAUSDnet operating system will record:

The Internet domain for your Internet service, such as "xdomain.com" or "xdomain.net" if you use a private Internet access account or "yourschool.edu" if you connect from a college or other education domain.

- The type of browser (such as Chrome version X or Safari version Y) that you are using.
- The type of operating system that you use (such as Macintosh, UNIX, or Windows.)
- The date and time you visit our site and the webpages that you visit on our site.
- The address of the previous website you were visiting. If you linked to us from another website.
- We use this information for statistical analysis and to help make the LAUSDnet site more useful to visitors. This tracking system does not record information about individuals.

Cookies

On certain LAUSDnet web pages, "cookies" are used to help with interactive usage of the site. A cookie is a small file that a website transfers to your hard disk, usually to keep track of you while you are connected to that site.

The cookies on LAUSDnet's pages do not collect information about you, but only about your browser "session." The cookie makes it easier for you to use the dynamic features of these web pages, without having to provide the same information again and again as you move from one page to another.

To protect your privacy, be sure to close your browser completely after you have finished conducting business with a website that uses cookies. If you are concerned about potential use of information gathered from your computer by cookies, you can set your browser to prompt you before it accepts a cookie. Most Internet browsers have settings that let you identify and/or reject cookies.

Information from Email

If you decide to send us an electronic mail message (email), the message will usually contain your return email address. If you include PII in your email because you want us to address issues specific to your situation, we may use that information in responding to your request. In other limited circumstances, we may be required by law to disclose information that you submit.

Also, email is not necessarily secure against interception. Please send only information to help us process your request.
