## Crisis Response

- Leads, organize and activate the crisis team in response to critical incidents on or near school campuses:
  - Grief Response
  - Suicide Assessments
  - Threat Assessments
  - Crisis Training
  - Linkage to Resources
  - Consultation
  - Direct services

- Assess impact on students, staff, school and community.
- Provide crisis counseling/support to students in classroom, group or individual sessions utilizing the components of Psychological First Aid (PFA).
- Training of crisis teams and team leaders.

## Professional Development

- Assist in the coordination of staff development workshops and training programs related to student wellness, violence prevention, conflict resolution, anti-bias related incidences, drop-out prevention and recovery, crisis intervention, and parent involvement programs for at-risk youth
