REPORT BY PAC CHAIRPERSON DIANA GUILLEN 2024-2025

Good Morning Parents!

"If we don't question the system, we become complicit in its crimes" (Abby Martin).

I want to welcome every one of you to this new cycle of meetings for this committee that is very important since it represents English Learners, low-income students and students in foster care. These students are those with the greatest needs and for whom our district receives approximately \$800 million more in grants to have an academic impact!

As the Board of Education, we evaluate the training provided by the Strategic Initiatives Office offered by Mr. Elward. To be honest, we are not satisfied because the idea was never to fill them with more uncertainty, which was the result, but to define the meaning of LCFF, LCAP, SENI, TSP etc., etc. But the goals were not achieved. So, they must once again provide the training according to our recommendations and not with what they want to provide us.

We have heard Superintendent Alberto Carvalho and the Board of Education on many media outlets repeatedly talking about students going up 2% on state exams at the district-wide level. The questions I want us to ask ourselves are:

Did this \$800 million impact these students from all 3 categories?

Were these students the ones who demonstrated an improvement in their academic levels? In your experience, think about how students were impacted in your schools where most of them were supposed to receive academic services, and if they received them, did they work?

Because this is our role as members, to question whether the services you purchase work and to be able to make comparisons from one school year to another.

At least, the information I have indicates that at least English learners had a 2% drop overall, and if we look at the data at the school-by-school level the data is much more disappointing.

We are beginning a new year and stand before a series of changes, that must not go unnoticed, as parents we have the privilege of having an impact in a positive way in our students' future. I am very grateful to the elected Board of Education which has shown leadership in continuing the work of the past cycle and we didn't start from scratch. To gain transparency and to ensure that our students are properly impacted, every parent on this committee is duty-bound to advocate for accountability and transparency.
