Project Title:

Murchison Elementary School - New Play Structures and Matting

Project Location – Specific:

The Murchison Street Elementary School New Play Structure and Matting Project (Project) will be located on the approximately 5.6-acre Murchison Street Elementary School campus (Murchison Street ES or Campus). The Campus is located on 1501 Murchison Street in the Lincoln Heights/El Serreno community of the City of Los Angeles. It is bound by Alcazar Street to the north, Murchison Street to the east, Lancaster Avenue to the south, and Tremont Street to the west. The Campus is located in an urbanized community primarily consisting of commercial uses, multi-family, and single-family residences.

Project Location – City: Los Angeles **Project Location – County:** Los Angeles

Description of Nature, Purpose, and Beneficiaries of Project:

The Project will add two new accessible play structures with integrated shade component and install approximately 2,800 square feet (sq.ft.) of DuraSAFE matting in the existing playground area. The Project will include two 16' x 16' x 14' play structures with footings at a depth between 8 to 12 feet. The new play structures and matting will serve students 5-12 years old at Murchison Street Elementary School (Murchison Street ES or Campus) (Exhibit A). The Board of Education approved the Project's budget of \$1,077,407 on November 19, 2024.

The Project will be implemented pursuant to all applicable State, federal, and local regulations and all applicable Los Angeles Unified School District (LAUSD) specifications, standards, and/or guidelines, including those in compliance with the California Environmental Quality Act (CEQA) and the updated Standard Conditions of Approval for District Construction, Upgrade, and Improvements Projects (SC) as adopted by the Board of Education on December 12, 2023.¹

Reasons why project is exempt:

Section 15301 - Existing Facilities

Class 1 consists of the operation, repair, maintenance, permitting, leasing, licensing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination.

The Project will add two new accessible play structures and will install approximately 2,800 square feet (sq.ft.) of DuraSAFE matting to an existing playground area. The Project will include two 16' x 16' x 14' play structures with footings at a depth between 8 to 12 feet. The new play structures will provide shade and address unmet Campus needs and provide students with an upgraded learning environment. Installation of play structures and matting will not present a new or expanded use of the Campus. Therefore, the Project fulfills the requirements of CEQA Guidelines Section 15301.

Section 15303 - New Construction or Conversion of Small Structures

Class 3 consists of replacing or reconstructing existing structures and facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced.

The Project will result in the installation of two new play structures and matting on the existing play yard that will include a shade component. The upgraded equipment and matting will address unmet campus needs and provide students with a safe

and healthy learning environment. Installation of the new equipment and matting will not result in an increase or alteration of the current use, function, or capacity of the existing Campus. Therefore, the Project fulfills the requirements of CEQA Guidelines Section 15303.

Section 15304 - Minor Alterations

Class 4 consists of minor public or private alterations in the condition of land, water, and/or vegetation which do not involve removal of healthy, mature, scenic trees expect for forestry or agricultural purposes.

The Project will include the installation of two new shade structures and matting that involve minimal land disturbance. Installation will not involve major grading, excavation, or other significant alterations to land. Installation of the new equipment and matting will not result in an increase or alteration of the current use, function, or capacity of the existing Campus. Therefore, the Project fulfills the requirements of CEQA Guidelines Section 15304.

Section 15311 – Accessory Structures

Class 11 consists of construction or replacement of minor structures accessory to (appurtenant to) existing commercial, industrial, or institutional facilities, including, but not limited to, on-premises signs and small parking lots.

The Project will include the installation of two new play structures with shade components and matting on the existing play yard. The new play structures and matting are consistent with the existing use of the Project area and will enhance playground experience and support the primary educational and recreational use of the site. The Project will serve as supplementary facilities to enhance the functionality of the existing playground. Therefore, the Project fulfills the requirements of CEQA Guidelines Section 15311.

Section 15300.2 – Exceptions

Section 15300.2 of the CEQA Guidelines, Exceptions, provides conditions under which categorical exemptions are inapplicable. Review of the Project indicates that they would not violate any of the exceptions, as described below.

1. The project would occur in certain specified sensitive environments or locations;

The Project will occur on an existing campus that is located within an urbanized setting. The surrounding uses of the Campus are residential uses to the north, south, east and west. The site is not designated as a biologically sensitive location. The nearest significant ecological area (SEA) is the Ballona Wetlands which are located approximately 5.8 miles east of the Campus.³ The nearest critical habitat is designated as such for the Coastal California Gnatcatcher and is located approximately 5.8 miles east of the site.⁴ As such, the Project will not impact sensitive environments or locations.

2. Cumulative impacts would be considerable because successive projects of the same type would occur at the same place over time;

The Campus is an active school site and there will likely be ongoing maintenance activities and minor projects on the Campus to keep the school operational. There are currently no known successive projects of the same type or scale planned for the Campus. As the Project would not result in any lasting impacts once construction of the Project is complete, the Project would not contribute to cumulative impacts when considered with expected

successive projects. Therefore, no cumulative impacts will result from the Project and successive projects of the same type and at the same place over time.

3. There is a reasonable possibility that the activity would have a significant effect on the environment due to unusual circumstances.

There are no known unusual circumstances that would have a significant effect on the environment. The removal of trees is not anticipated as part of the proposed scope of work. However, should the Project be altered to include the removal of trees, the District's Office of Environmental Health & Safety (OEHS) must be notified immediately. District policy requires consultation with an arborist to determine if the trees are a protected native species. All tree trimming and removal conducted on District property is required to adhere to the procedures described in the LA Unified OEHS Tree Trimming and Removal Procedure.⁵ Additionally, written approval from the school principal will be required before any trees can be removed. If tree removal is scheduled to occur between February 1 and August 31, a nesting bird survey would be performed prior to removal activities, per SC-BIO-3.

The Project will include minor ground-disturbing activities. These activities are not considered unusual circumstances for the classes of projects under which an exemption is claimed. Nevertheless, consideration must be given to the management of pavement removal and excavated soils associated with earthwork activities for the Project. As the Project involves the removal of pavement, soil sampling and testing for characterization is required prior to demolition and removal of the paving materials. If construction or earthmoving activities require import or export of soils and materials, OEHS must be notified to provide oversight to ensure that these activities are conducted in compliance with the requirements of District Specification 01 4524, relevant provisions of South Coast Air Quality Management District Rule 1466, and other applicable environmental agency rules and requirements.⁶ Furthermore, as set forth in SC-CUL-6, SC-CUL-7, SC-CUL-10, and SC-CUL-11, construction activities must be stopped immediately and OEHS notified upon discovery of subsurface features, such as buried resources (i.e., paleontological resources, archaeological resources), tanks or seepage pits, or stained/odoriferous soils. Lastly, any construction and demolition waste shall be recycled to the maximum extent feasible per SC-USS-1. Therefore, the Project will not have a significant effect on the environment due to unusual circumstances.

4. The project may result in damage to scenic resources, including but not limited to trees, historic buildings, rock outcroppings, or similar resources within a highway officially designated as a state scenic highway;

The closest designated state scenic highway to the Project site is the Topanga Canyon State Scenic Highway, a 2.5-mile portion of State Route 27 (SR-27), which is located approximately 22.5 miles west of the Campus.⁷ The Project will not result in the removal of historic buildings, rock outcroppings, or other scenic resources. Therefore, the Project will not result in damage to scenic resources or similar resources within a highway officially designated as a state scenic highway.

5. The project is located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; or

The Project will occur on an existing school campus which is not included on any list compiled pursuant to Section 65962.5 of the Government Code.⁸ Therefore, the Project will not have an impact related to being located on a hazardous waste site.

6. The project may cause a substantial adverse change in the significance of a historical resource.

The LAUSD Historic Preservation Specialist determined that Murchison Street ES is ineligible as an historic resource.⁹ Therefore, the Project would have no impact on a historic resource.
