CONSULTATIONS FOR U-VISA AND VAWA

Our Survivors of Violence Unit represent individuals who qualify for U-Visa, VAWA, or T-Visa.

To obtain a consultation, make an appointment with a library, Family Source Center, or visit our main offices in Los Angeles or Van Nuys (see back side for hours). No appointment is required at our main offices.

For the U-Visa: Bring a copy of the police report, court documents, or Department of Children and Family Services (DCFS) report.

For VAWA: Bring proof of the aggressor's legal status, marriage certificate, and proof of any abuse.

UNACCOMPANIED MINORS

Our Unaccompanied Minors Department represents individuals who entered the country as minors and were officially designated "unaccompanied minor" by immigration authorities.

These minors were placed in a shelter before being reunified with a parent, relative, or friend. We represent them in immigration court and with the office of Citizenship and Immigration Services (USCIS).
