Job Description: Provide competency-based instruction to parents and families of learners of exceptional needs based on DACE course outline. Provide direct instruction to advance parent/family engagement, develop parent/family leadership, and strengthen parent/family networks. Facilitate opportunities for families to leverage existing assets to support the academic success and socio-emotional wellness of learners of exceptional needs.

Salary: The salary will be based on the current negotiated Teacher Hourly Rate.

Duties:

- Plan and deliver instruction using DACE course outlines.
- Maintain accurate records of attendance and progress
- Offer differentiated and varied instruction to address the educational needs of LAUSD parents and guardians
- Maintain a learning environment designed to stimulate interest and attendance that is also conducive to maximum learning
- Administer and meet deadlines for DACE-SIS (DACE Student Information System) attendance rosters and other required data forms
- Other related duties as assigned in accordance with LAUSD/UTLA Bargaining Agreement

Preferred Qualifications:

- Experience providing instruction to parents/guardians
- Knowledge of DACE course outlines
- Knowledge of Special Education process
- Skillful at verbal and written communication
- Proficient in Microsoft Outlook, Google Workspace, Zoom and Schoology
- Skillful at differentiating instruction, establishing clear lesson objectives and making course content accessible to students
- Skillful at classroom management, including small group and pair configurations
- Able to build and maintain a learning environment designed to motivate and retain students
- Committed to professional growth and ongoing participation in professional development
- Effective organizational, interpersonal, written, and verbal communication skills

Minimum Qualifications:

- Must hold a valid Secondary Credential, Multiple Subject Credential or Clear/Preliminary Adult Designated Subjects Credential with emphasis on Academic Subjects
- LAUSD Child Abuse Awareness Training certificate
